







This year marked transformative growth for the Charlottesville Free Clinic. We provided 16.7% more patient visits through our medical, dental, and mental health services, with our small staff and over 600 volunteers delivering \$611,524 in donated healthcare. Our digital dentistry program alone created 89 new smiles through partial dentures and protective guards, restoring not just oral health but the confidence patients need to interview for jobs and care for their families.

Free Clinic patients come from nearly **800 different employers across our region**—the cashiers, cooks, caregivers, and essential workers who keep our community running but lack access to affordable healthcare.

Behind these numbers are stories of profound gratitude and transformation that remind us why this work matters. None of this happens without partners like you who understand that healthcare is a cornerstone of community stability.



New at the Clinic: Physical Therapy

Meet Jocelyn "Jo" Reeder, PT, DPT — the driving force behind the Free Clinic's new physical therapy program. Jo says that it was her dream after retirement to make physical therapy accessible to those who might otherwise go without. In just a few short months, she has helped turn that vision into reality.

Thanks to dedicated therapists like Jo and Judy Zacharias, patients can now receive in-house physical therapy for a wide range of conditions that impact their daily lives.



A Network of Care for Complex Cases

Nina arrived at the Free Clinic after a visit to the ER, where she had experienced a racing heart, chest pain, overwhelming anxiety, and an itchy rash that seemed to appear from nowhere. The ER discovered problems with her thyroid, prescribed a medication, and discharged her with instructions to "find an endocrinologist"—a nearly impossible task for someone without insurance. Fortunately, Nina found the Free Clinic.

At the Free Clinic, Nina saw several specialists but her condition mysteriously worsened and the angry, inflamed rash spread across her skin, robbing her of sleep and peace. As a full-time caregiver for children, Nina couldn't take prescribed medications that would have left her drowsy during the day, leaving her with few options. During a visit with a volunteer endocrinologist, Nina broke down in tears. The rash now covered 80% of her body, and she was at her breaking point, but strangely, her thyroid problems had resolved spontaneously.

The Free Clinic activated its partnerships and fast-tracked Nina to UVA Dermatology within just two days. She was provided specialized treatment that would have typically required months of waiting and been financially impossible for Nina to access on her own. Nina's story exemplifies how the Free Clinic's collaborative model can transform lives.

A New Era: Digital Dentistry

We're expanding care with digital dentistry and 3D printing, which allows us to do more than remove diseased teeth—it enables us to replace them quickly and affordably.

In just 3 months, we've provided 14 removable partial dentures and 75 occlusal guards—restoring 89 smiles.

In the past, patients had to cover the cost of replacement, often amounting to six months' worth of wages. By replacing damaged teeth, we're not just improving oral health; we're helping patients regain confidence and the ability to support their families.



Integrated Care in Action

When Jose arrived at the Free Clinic's dental clinic, he was in excruciating pain from a severe mouth infection that had kept him awake for days. The 52-year-old cook hadn't seen a dentist in over a decade, and the neglect had taken its toll. The team quickly addressed the emergency, saving one tooth with a root canal and extracting another beyond repair.

During treatment, Jose mentioned constant thirst, unexplained weight loss, and daily exhaustion. Recognizing the warning signs, the dental team referred him to the Free Clinic's medical providers, who diagnosed uncontrolled diabetes—a condition behind his repeated infections and poor healing.

What began as an emergency dental visit turned into a multi-year health journey. With his diabetes under control through medical care, Jose was able to complete extensive restorative dental work. Thanks to partial dentures, he now has a complete smile and renewed confidence.

Today, Jose only returns for maintenance visits, with his oral health strong and diabetes better managed.

A Lifeline in a Time of Need

As someone living with diabetes, Mr. Wicker was no stranger to the high cost of life-saving medications. But after a serious workplace accident left him unable to work, his situation quickly became critical. Although he was able to undergo a necessary knee replacement surgery while still insured, the recovery period brought new challenges: he was out of work, not yet eligible for Medicare, and quickly overwhelmed by the cost of medications and physical therapy.

"I was drained," Mr. Wicker recalls. That's when he turned to the Free Clinic. Here, he found not only the support he needed, but a community that helped him bridge the gap. The clinic provided his essential diabetes medications and physical therapy at no cost, giving him the resources to fully recover. Thanks to the Free Clinic, Mr. Wicker is finally pain-free after his surgery, and he's not stopping here—with progressive vision loss, he'll be back soon for an eye exam and new glasses.

To other patients and donors, Mr. Wicker shares a message of gratitude: "I am extremely blessed. After all that's happened to me, I know life is a gift—and I can keep on going."


